COMMISSION OF PUBLIC WORKS


Finance Director Goff's report attached as information. Overall, office operations are running smoothly.


James Robinson ~ Superintendent:

Adam Hedden ~ General Manager:

General Manager Hedden reported that the Raw Water Intake Project has been returned to Turnipseed Engineers.

General Manager Hedden reported that he is still in negotiations for a piece of property to help with the construction for the water plant.

General Manager Hedden reported that wholesale power proposals have been received and are in the process of being analyzed by Summit Utility Advisors.

General Manager Hedden presented the Commissioners with a draft of the Standard Interconnection Agreement for Customer-Owned Renewable Generation System. GM Hedden requested that the Commissioners review it and make any suggestions before the November regular meeting.

General Manager Hedden presented the new purchasing policy to the Commissioners. (Copy available in CPW Office).

On a Motion by Commissioner Bowick, seconded by Commissioner Long the Commissioners were in agreement to approve the Purchasing Policy.

General Manager Hedden presented proposals for outsourcing bill printing and the cost savings as a result of outsourcing. GM Hedden recommended the Commissioners contract South Data for outsourcing bill printing based on cost savings per year, user friendly system, and South Data has customers that are presently using Southern Software the CPW's software provider. South Data will coordinate the necessary programming with Southern Software (attached cost saving comparison). There will be a \$ 300 upfront cost, estimated cost of .72 cents per bill, which will include bill printing, postage, sort and mailing the bill.

GM Manager Hedden reported that the CPW is not required to mail delinquent notices. The present and the new CPW utility bill states that utilities are subject to disconnection if not paid by the 20^{th} of the month.

General Manager Hedden recommended the Commissioners contract Payment Service Network, Inc. (PSN). PSN provides the option for the customer to pay by phone, text and internet payments 24 hours per day 7 days per week. Payments can be made with credit card, debit card and E-check. Customers will have the option to speak to a live attendant that will walk them thru the payment set up and payment. The customer will be charged \$4.00 per transaction.

On a Motion by Commissioner Long, seconded by Commissioner Bowick the Commissioners were in agreement to contract South Data to outsource utility billing and contract Payment Service Network, Inc. (PSN) to provide internet payments.

General Manager Hedden requested to go into executive session in regard to negotiations incident to proposed contractual agreement.

On a Motion by Commissioner Bowick, seconded by Commissioner Long the Commissioners were in agreement to go into executive session in regard to negotiations incident to proposed contractual agreement.

No action was taken during executive session and the meeting reconvened.
